Community Amateur Sports Club Scheme (CASC)

CASCs will not pay tax on the following if the money they receive is used for qualifying purposes:

- Bank interest.
- Gift Aid donations, including donations made by a trading company that's owned by the applicants CASC (tax can be claimed back).
- Capital gains (profit from selling or disposing of an asset).
- Trading profits if the applicants turnover is less than £50,000 a year (£30,000 before 1 April 2015).
- Income of up to £30,000 a year from renting out property (£20,000 before 1 April 2015).

If the money comes from the CASCs members with full voting rights they will not pay tax on:

- Income from membership fees.
- Profits from selling food and drink relating to the club's sporting activities, eg a members bar.

Community Amateur Sports Clubs - Tax Relief

Funding Body: HM Revenue and Customs (HMRC)

Description:

A range of tax relief measures with the aim of supporting UK community amateur sports clubs (CASCs).

Sports clubs of the kind that are eligible to register as CASCs are treated as companies for tax purposes. Consequently, their profits may be chargeable to Corporation Tax.

Sports clubs that are registered as CASCs are able to claim the following tax reliefs:

- Exemption from Tax on profits from trading where the turnover of the trade is less than £50,000.
- Exemption from Tax on income from property where the gross income is less than £30,000.
- Exemption from Tax on bank interest.
- Exemption from Tax on capital gains.
- Exemption from Tax on gift aid.

All of the exemptions depend upon the club having been a registered CASC for the whole of the relevant accounting period and the income or gains being used only for qualifying purposes.

Relief for donors

There is a range of tax reliefs to encourage individuals and companies to support CASCs:

- Individuals can make gifts to CASCs using the Gift Aid Scheme.
- Individuals can include the gross value of Gift Aid donations to CASCs when making a Tax Credit application, or when computing age-related personal allowances.
- Individuals can obtain relief from Inheritance Tax for gifts to CASCs. Gifts will not form part of the donor's estate for inheritance tax purposes, in the same way as gifts to charity.
- Business that give goods or equipment that they make, sell or use, get relief for their gifts. They do not have to bring any disposal amount into account, but can still obtain relief for the cost, for tax purposes.
- Gifts of chargeable assets to CASCs by individuals or companies are treated as giving rise to neither a gain nor a loss for Capital Gains purposes.

There are rules to prevent exemptions for CASCs and the donor reliefs being used for tax avoidance purposes.

Gift Aid

Individuals who are UK taxpayers can make gifts to CASCs using Gift Aid, in the same way as they can make gifts to charities. Relief is available for gifts made to a registered CASC after 6 April 2002. Gift Aid is only available for gifts to CASCs, and not for other payments such as membership subscriptions.

A CASC can reclaim basic rate tax on donations made by individuals, whether large or small, regular or one-off, provided the conditions for the Gift Aid scheme are satisfied.

The rules of the Gift Aid scheme for individuals, as they apply to charities, also apply to registered CASCs (a CASC's membership subscriptions are NOT eligible as Gift Aid payments).

Gifts made using Gift Aid are treated as having been paid after deduction of Basic Rate income tax. As long as the CASC applies the income for qualifying purposes it can claim repayment of this tax from HMRC Charities (at present 28p for each £1 donated (while the Basic Rate of income tax remains at 22%)).

If the donor pays tax at the Higher Rate, they can claim additional relief in their SA tax return. All they need to do is enter the amount paid to the CASC in the Gift Aid box on their SA return.

Companies cannot make gifts to CASCs using Gift Aid, but can normally claim a deduction in computing their profits for either formal sponsorship of a sports club, or for payments made to enhance their standing in the local community.

Rate Relief

For CASCs in England and Wales, Section 64 of the Local Government Act 2003 provides the same relief that would be available to a charity (80% mandatory relief) where the CASC property is wholly or mainly used for the purposes of that club and of other such registered clubs. With effect from 1 January 2006, CASCs in Scotland became entitled to the same mandatory 80% rate relief.

Waste Recycling Environmental (WREN) - FCC Scottish Action Fund

Third Party Funding

Under the Landfill Communities Fund, Waste Recycling Group Ltd can voluntarily pass to WREN a percentage of its Landfill Tax bill for distribution to suitable projects. Of this, the Government only allows WRG plc a 90% credit against this amount.

In order to mitigate the losses incurred by participating in the Scheme, Waste Recycling Group (as a condition of providing WREN with the Landfill Tax Credits) requires project applicants to secure the help of eligible 'Third Parties' who will reimburse them with an amount equal to 10.75% of any grant committed. The figure of 10.75% also takes into account the automatic levy charged by the scheme's regulator SEPA together with a proportion of the costs associated with administering the grant.

The key consideration regarding Third Party funding is the term 'Unique Benefit'. Simply, a Third Party funder cannot gain any unique benefit from the project put forward for funding.

Examples of organisations which can be Third Party funders are as follows:

- Private companies.
- Public sector organisations such as local authorities or county councils.
- Charities.
- Voluntary organisations.
- Private donors.
- A person who shares the benefits with others, for example, a member of a church congregation or a person who uses with others, a village hall or other community facility.

The 10.75% amount should not be included as part of the grant application and must not be included in the project funding calculations. The Third Party funding transaction, while facilitated by WREN, is a transaction outside the realms of the project and its associated costs. The payment is made directly from the Third Party funder to the landfill operator, Waste Recycling Group.
